Examples include:

- Charitable or humanitarian work
- Outstanding teaching
- Excellence in clinical practice
- Innovative research program
- Leadership during community outbreak of infectious disease
- Establishment of training program in family violence
- Innovations in developing a new program to address a health care need
- Leadership role in a hospital or regional health care program.

Recipients of the Awards of Excellence will be recognized by their Chapters at their Annual Scientific Assembly/Annual General Meeting and/or other Chapter events. The recipients will also be recognized during Family Medicine Forum (FMF) 2011 3-5 November in Montreal.

Nomination Process

Nominations are invited from CFPC members and the public and must be submitted to the Chapter office of the nominee. The deadlines for submission vary according to each Chapter.
